NOTE TO PHYSICIAN

If serum calcium levels are elevated, treatment with Calcitonin is effective in reducing calcium to normal levels. Continue monitoring serum calcium and treat as necessary for hypercalcemia (Reference, AMA Drug Evaluations, Third Edition (1977), Chapter 16, pp. 248-251).

TREATMENT FOR PET POISONING

NOTE TO VETERINARIAN

Calcium Mobilizer Cholecalciferol: For animals ingesting bait, induce vomiting by using hydrogen peroxide or administration of activated charcoal with a cathartic. If clinical signs develop, treatment consisting of saline diuresis combined with the use of furosemide, corticosteroids, and phosphate binders are recommended. Calcitonin or pamidronate may be needed for animals that remain hypercalcemic despite symptomatic treatment.

DIRECTIONS FOR USE (Continued from other panel)

- 1. Store unused product out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by does and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait, if bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. Stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to
- 3. Dispose of product container and unused, spoiled, or unconsumed bait as specified on this label.

USE RESTRICTIONS: This product may only be used to control the following rodent pests in and around man-made structures: House mouse (Mus musculus), Norway rat (Rattus norvegicus), Roof (Rattus ratus), Cotton rat (Sigmodon hispidus). Eastern harvest mouse (Reithrodontomys humuli), Golden mouse (Ochrotomys nutralli), Polynesian rat* (Rattus exulans), Meadow vole* (Microtus pennsylvanicus), White-throated woodrat* (Neotoma abigula), Southern plains woodrat* (Meotoma micropus), Bushy-tailed woodrat* (Neotoma cinerea) and Mexican woodrat* (Neotoma mexicana). This product must be used in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops. Burrow baiting with TERAD-98 Blox is prohibited.

Do not place bait near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. When used in USDA inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.

Do not sell or distribute this product in individual containers holding less than 4 pounds of bait.

SELECTION OFTREATMENT AREAS: Determine areas where rats, house mice or meadow voles* will most likely find and consume the bair, Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where signs of rodents have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS:

Rats: Place 2 to 8 blocks per placement (usually at intervals of 15- to 30- feet). Maintain an uninterrupted supply of fresh bait for 10 days or until there no longer are signs of recent feeding on bait by rats.

House Mice, Eastern Harvest Mice*, Golden Mice* and Meadow Voles*: Use 1 Block per placement. Space placements at intervals of 8- to 12-feet in infested areas. Larger placements, up to 2 Blocks, may be needed at points of extremely high house mouse or meadow vole* activity. Maintain an uninterrupted supply of fresh bait for 15 days or until there no longer are signs of recent feeding on bait.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using waterproof gloves, collect and properly dispose of all dead, exposed animals and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish them as needed.
