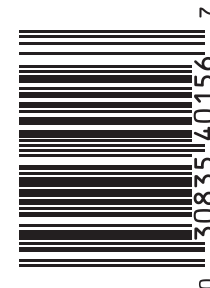

1. Store unused product out of reach of children and pets.

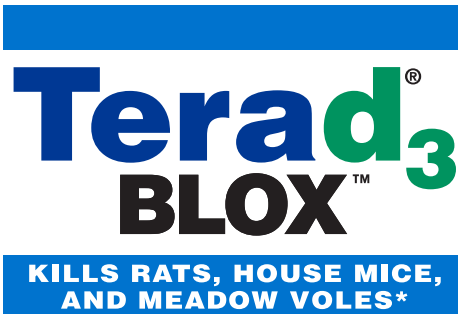
